Resident Activities: both buildings are very active; city coming close to end of Affordable Housing study, will present at December 16 meeting; County meeting on Section 8 housing with landlords to develop good, safe, affordable housing; summary of responses to comments from last meeting; scheduling resident advisory board meeting in late January; town hall meeting; website will be improved as more information becomes available; meeting set with communications consultant for work next year; partnering with P&R department with free membership to Senior Group; piloting free rides on SMART through end of January – goal for free ridership. Applied for Ross Grant for transportation – winter 2020 for announcement of award
