E. Executive Director's Report

Van Poucker relayed Public Housing operational reports for the month including pest control, lease violations/warnings, occupancy and work orders.

The front driveway at Withington is complete and open. It has a larger turn-in radius and wider barrier-free entry in front.

Proposals to provide laundry vending to our buildings are due November 30.

ROSS Grant/Social Work activities continue with free markets at both buildings and deliveries to scattered site homes. Becky is coordinating with Ferndale Parks/Rec on arts/crafts and pen pals for seniors. Thanksgiving dinners will be delivered by Westminster Church and resident volunteers will coordinated pick-up at both buildings. "Deck the Halls" door decorating contest will begin December 1. The Social Worker reported 76 services provided to 11 individuals. The IDEA survey is underway. We hope to receive at least 20% overall response rate (around 200 surveys). We've received 186 to date. We've received 8 resident/HCV participant applications to serve on the Task Force.

The County provided free Covid-19 testing for all adult FHC residents and staff on 10/23/20. We had strong participation and zero positive cases. Free flu vaccine clinics were held at both buildings. We have reverted to nearly 100% remote office with staff in office only as necessary. Maintenance is on urgent/emergency work orders only. The buildings remain on essential-visitors-only and no gatherings of any size.
