1. Roll Call

3. New Business

a. Presentation of Annual Report

Heather Van Poucker gave the FHC Annual Report to quantifying FHC activities and analyzing the results of operations. The report included general demographics of the public housing and housing choice voucher programs.

Van Poucker expanded on the HCV program showing population and geographic distribution of participants as well as payment standards by room size, age of housing and tenant rent portion. She also discussed the lack of affordable housing and affordable housing developments and the issue of participants facing 'source of income' discrimination regarding using the housing choice voucher as payment for rent.

The annual report included metrics of the public housing program showing how FHC addresses resident complaints, lease violations and evictions as well as how work orders are addressed.

Van Poucker included a breakdown of supportive services programming showing details and metrics of the ROSS program and social work services provided. Services included mental health and service coordination for residents. FHC arranged and coordinated On-Site vaccine and booster clinics, addressed food insecurity with on-site pantries and food delivery to scattered site homes, partnered with members of the community to provide activities and programming, developed more methods of communicating information to residents, and provided a computer lab and computer classes for residents.
