7. Executive Director's Report

Heather Van Poucker reported on pest control, lease violations, occupancy, delinquencies, and work orders completed at buildings and scattered site properties.

FHC has passed the annual HUD/REAC property inspection which was completed in early October. City Inspections are scheduled for early December.

Van Poucker stated that a new Property Maintenance Technician has been hired and will be starting in early November. Bill Willcock has skilled maintenance experience, including as an electrical journeyman and building maintenance. He has been a Team Leader for Ferndale DPW and has strong ties to the City of Ferndale. He will have a dedicated maintenance office at Autumn House and will work with Jose as a team on scattered site needs, and at the buildings on two-person jobs.

We continue to work with the City to finalize language on agreements to remove the City from titles of scattered site properties.

8. ROSS Program Coordinator Report

Becky Prickett reported activities and events at Withington and Autumn House for the month of September and plans for October.

Training dates have been scheduled in November and December for ACES (Adverse Childhood Experience) and Mental Health First Aid. Opportunity to participate will be made available to FHC Board members, FHC staff, FHC residents, community members, and Ferndale Fire Fighters/Police.

Thanksgiving dinners for residents at both buildings will be provided by Westminster Church. Computer Basics classes are going to be scheduled soon. The individuals who taught last year have unfortunately had to cancel teaching this year, so a replacement is being sought. The 2022 ROSS Report is due October 30th.
