Karen Hicks (Withington) asked if the awnings for the balconies were going to be installed this year.

Janean Shackleford (Withington) voiced concerns about pest issues in the area of the south patio and that the side entrance light was out on the south side of the building. Ms. Shackleford also mentioned that a non-resident has been seen in the south vestibule.

 The presentation was cancelled due to technical difficulties. Emily Tong will reschedule for the next FHC Board Meeting occurring on August 21, 2023.

7. Executive Director's Report

Emily Tong reported on pest control, lease violations, occupancy, delinquencies, and work orders. The rain barrels that the City of Ferndale provided have been installed at 40% of the scattered site homes and completion is expected by the end of the month. Documentation has been distributed to all SS homes regarding the use and care of the rain barrels.

Ms. Tong collaborated with our property and liability insurance company, Kapnick Insurance, to reduce the 2022 Workman's Compensation Premium. A calculation error was determined to have been made by The Aprise Group. The premium has been reduced to \$5,4000.23 and FHC will receive a refund in the amount of \$5,184.63.

Emily Tong reported social work services for the month of June.

8. Old Business

a. Hiring Update for HCV Specialist and Deputy Director/Public Housing Manager Emily Tong reported on the final candidates for HCV Specialist and Deputy Director/Public Housing Manager. Commissioner Martin stated that the FHC Board members would like to give feedback. Emily Tong will forward the applicants' resumes to the FHC Board members for review and input before an official offer is made to the candidates.

9. New Business

a. Approval of Proposed 2023 Utility Allowances for Public Housing & HCV Programs Emily Tong reported that Nelrod Company reviewed utility allowances and they have increased by 10%. The increase in utility allowances will go into effect for October 2023 recertifications. Commissioner Martin asked how FHC utility allowances compared to other PHA's. Tong stated that she would check with other directors with similar sized PHA's.
